# Information on sampling



## Olive oil:

The needed amount of olive oil for an analysis is very low. For the possibility of multiple measurement in case of doubts please send us at least 50ml in a suitable and well closed container. You can also send original closed sales containers. The description of the sample container is part of the analysis report.

## Deep-frying oil:

The needed amount of frying oil for an analysis is very low. Please send us at least 50ml in a suitable and well closed container. Please do not send larger quantities as this will result in unnecessary waste disposal. Please filter the oil sample roughly to eliminate any residues of solids that can lead to measurement errors.

## General:

Please ensure that your samples are labeled clearly legible. Waterproof markers are not oil resistant, which is why labels can smear or disappear as a result of contamination or minimal leakage. The sample containers should be free of grease residues before labeling.

## Procedure:

Usually the analysis of the samples submitted and the transmission of the results by e-mail are done within 2 business days after receipt of the sample material. Depending on the order density the duration may be longer in individual cases.

We do not send any acknowledgment of receipt. Please refer to the tracking services provided by the package services.

The original test report will be sent to you by post, along with the invoice. Please pay within 14 days of receipt.
